Approve Amendment #1 with Sun Street Centers for Men's Sober Living Environment (SLE) for a fee-for-service contract in an amount of \$8,131.00 for a total contract amount not to exceed \$152,131.00 for the term July 1, 2024, through June 30, 2026, to increase bed utilization of this contract, authorize Chair to sign said agreement, and approve Budget Adjustment for \$8,131.00 covered by an existing appropriations under the expected federal Medi-Cal revenue.

BACKGROUND/SUMMARY:

This contract allows the Behavioral Health Department to purchase Sober Living Environment (SLE) beds for male beneficiaries on a fee for service basis. This men's SLE is a separate residence service from the women's SLE provided by Sun Street Centers. This resource allows for a local placement option for men needing this level of supervision when mandated by other local agencies including Probation and the Court system.

Sun Street Centers's SLE differs from other residential providers as there is no treatment provided at this location but this environment is utilized to allow men to live in a sober space while attending mandated or voluntary treatment at San Benito County Behavioral Health. SLEs provide 24-hour safe, residential housing in a setting that is free from alcohol and other drugs. Most referrals to this provider are made through our MOU with Probation and CPS to provide a sober living space for community members receiving mandated treatment. Sun Street Centers is licensed and is beholden to the California Consortium of Addiction Programs and Professionals (CCAPP) SLE Standards.

This contract will allow for the purchase of four (4) guaranteed, dedicated beds and availability for the placement of 4 male clients every month as males exhibit higher utilization of this service compared to females.

Due to the increase in clients needing this type of service San Benito County Behavioral Health will at times pay for additional bed over the 4 guaranteed in the contract to meet client demands.

RFP AND BID HISTORY:

Based on the BOS presentation from January 25, 2022, this contractor's facility falls under the category of SUDs Treatment Contracts that include Residential facilities. An RFP for this type of contract is not advised because these type of fee for services contracts are secured in the event an individual presents themselves needing this level of care and needs to be placed at this type of facility. SBCBH tries to contract with qualified and licensed facilities of this type in the surrounding area to adhere to time and distance standards.
