BACKGROUND/SUMMARY:

County Service Areas Road Surface Repair Project PWB-2522 is a road surfacing repair project for CSA 16 (Santa Ana/Holiday Estates), CSA 24 (Santa Ana Acres), CSA 48 (Dry Creek), and CSA 51 (Comstock Estates). The scope of work includes, but is not limited to, pavement spot repairs of approximately 38,729 SF of crack sealing and approximately 704,004 SF of slurry seal Type II, associated striping removal and replacement, refreshing of existing painted street markings, traffic control and installation of necessary environmental pollution prevention requirements on the various CSA streets. The funding for the project was approved by the Board of Supervisors.

FISCAL IMPACT:

The project funding has been approved in the FY 25/26 County budget. The funding for the project will be accomplished through the following G/L Codes:
