**CONTRACT AND RFP HISTORY:**

This will be the 7th amendment to the contract with Nolte and Associates Inc. to perform additional services for the design of the Anzar Road Bridge Replacement project at Arroyo Dos Picachos, for an additional amount not to exceed \$61,150.00. The revised scope of services includes coordination and construction document work pertaining to environmental permitting and mitigation planting, and construction support services.

The original contract was approved, following an RFP process, on June 19, 2012, for \$314,238.00. The first amendment, which included additional services for an additional \$13,714.00, was approved on June 4, 2013. The second amendment, which extended the contract term and included additional services for an additional \$35,286.00, was approved on June 28, 2016. The third amendment, which extended the contract term at no additional cost, was approved on June 12, 2018. The fourth amendment, which included additional services for an additional \$150,000.00, was approved on August 7, 2018. The fifth amendment, which extended the contract term at no additional cost, was approved on May 21, 2019. The sixth amendment, which extended the contract term at no additional cost, was approved on October 29, 2021. Approval of the 7th Amendment will increase the total contract to an amount not to exceed \$574,388.00,
