**BACKGROUND/SUMMARY:**

The County of San Benito Resource Management Agency is collaborating with [Keep America Beautiful](#), Keep California Beautiful, San Benito Resource Conservation District, Point Blue Conservation Science, San Benito County Historical Society, Xerces Society for Invertebrate Conservation, and REACH Parks Foundation to host a Community Action Day event focused on pollinator planting, vegetation removal, and beautification efforts at the San Benito County Historical Park. Keep America Beautiful will provide up to \$10,050 in funding for the event. This includes up to \$9,000 for event supplies to support up to 70 volunteers, and an additional \$15 per volunteer (up to \$1,050) for food, refreshments and related expenses. All event costs will be paid directly by Keep America Beautiful, the San Benito Resource Conservation District, and the San Benito County Historical Society. The event is scheduled for October 25, 2025.

**Community Action Days - Memorandum of Understanding (MOU) Background**

An MOU between Keep America Beautiful (KAB) and the County outlines event objectives,

responsibilities of each entity, and reimbursement thresholds by KAB to the County.

**FISCAL IMPACT:**

No fiscal impact. All event costs will be paid directly by Keep America Beautiful and the San Benito Resource Conversation District.
