#### BACKGROUND/SUMMARY:

On June 16, 2021, in accordance with the provisions of County Code section 25.43.05 of the County of San Benito, State of California, Conditional Use Permit (PLN190056) was granted to Assessor's Parcel Number 012-030-045 to build an agricultural facility on the 104-acre parcel, located near the interchange of San Juan Highway and Anzar Road, in an unincorporated area of San Benito County. The project is located on the west side of San Juan Highway and just north of Anzar Road.

Condition of approval No. 20 requires the applicant to dedicate 12 feet in width of land for public right-ofway along the entire property frontage of San Juan Highway, and 10 feet in width of land for public rightof-way along the entire property frontage of Anzar Road. To fulfill a portion of said condition, ADK Holdings, LLC and JBK Holdings, LLC executed a right-of-way dedication grant deed in favor of the County for 12 feet in width right-of-way along the whole property frontage of San Juan Highway.

Government Code section 27281 requires the County's acceptance of grants of property interests to be

reflected in a Resolution of the Board of Supervisors.
