BACKGROUND/SUMMARY:

The Lands of Lee development project was denied by the Planning Commission in 2022-23. As a result of this outcome, no appropriations were budgeted for the development. However, the applicant has decided to continue with their application. The Applicant submitted an amended application and revised EIR draft on October 30, 2023, that included but not limited to updated VMT, updated Affordable Housing piece, deleted wastewater option, updated stormwater runoff, and other items within the denial. Planning staff reviewed and worked on amended application and published the amended public draft EIR on May 10, 2024. Planning staff is working to bring amended project application to Planning Commission and the Board of Supervisors later this year. Consequently, approved appropriations are required in order to provide a budget to pay costs against it. The estimated cost for the year is \$43,000.00. This cost is to be reimbursed by the applicant/developer.
