The Workforce Development Board (WDB) requests the new appointments of Andrew Shelton, Ashley Rule and Roger Gilbert to the Workforce Development Board (WDB) as Private Sector Representatives, and Denise Dorsey to represent the Public Sector, for a (3) three-year term, effective February 11, 2025 through February 11, 2028.
