Approve Amendment No. 1 with Bright Future Recovery for an additional amount of \$275,465.00 for a fee for service contract total not to exceed \$950,915.00 to accommodate the increase utilization of this services for Adult Residential Substance Use disorder treatment, recovery services, and withdrawal management services for clients in San Benito County, for the term ending on June 30, 2025, authorize chair to sign said agreement, and approve Budget Adjustment for \$275,456.00 covered by an existing appropriations under the expected federal Medi-Cal revenue.

**BACKGROUND/SUMMARY:**

Clients sometimes require placement in substance abuse residential treatment facilities as part of their treatment plan. Provider options are important to maintain client Freedom of Choice requirements and when it is determined to be conducive to client recovery to create distance away from negative influences that may exist within their home community. This contract provides licensed residential substance abuse treatment services for San Benito County adults. Individuals involved in this type of treatment are generally participants of court ordered mandated substance abuse treatment. The residential and other ancillary services provided through this contract are eligible for funding through Child Protective Services (CPS), Probation Dept. AB-109 funding and DMC-ODS reimbursement. This is a Fee for Service contract and reimbursement is dictated by use and as such the total dollar amount of this contract can range from zero to the maximum dollar amount of the contract.

This provider's services are needed to ensure that there are treatment options and bed availability for the

client in the event that other options are at capacity and/or the client and counselor anticipate that the client will respond better to their structured treatment model.

**OTHER AGENCY INVOLVEMENT:**

The County Superior Court, Probation and CPS staffs often work in coordination with Substance Abuse Treatment staff in identifying clients who are appropriate for access to this level of residential care.

This is a fee for service contract. FY 24-25 was the first time San Benito County Behavioral Health has contracted with Bright Future Recovery. Staff tried to estimate the number of clients who would need to utilize these services however staff estimates were below the actuals amendment is adding the necessary funding for payment remittance.
