BACKGROUND/SUMMARY:

California Mental Health Services Authority (CalMHSA)'s multi-year Healthcare Effectiveness Data and Information Set (HEDIS) Performance Measurement Participation Agreement will support participating counties including San Benito County in meeting the Behavioral Health Accountability Set (BHAS) Healthcare Effectiveness Data and Information Set ("HEDIS") reporting requirements. HEDIS is a standardized set of performance measures to evaluate and report on the quality of care including client experience.

Currently, this Participation Agreement offers *only deliverables associated with Measurement Year 2025/Reporting Year 2026 (MY25/Ry26)*. The \$21,000 is a fixed fee for the MY25/Ry26 deliverables included in the “Simple Bundle” offering. For future years beyond MY25/Ry26, CalMHSA will offer amendments to this contract which will add new scopes of work and associated pricing for future years’ deliverables. Counties will have the option to choose whether they want to purchase those future years’ scopes of work once they are offered. For now, only MY25/Ry26 deliverables are offered.

FISCAL IMPACT:

Participation in CalMHSA's HEDIS fulfills Department of Health Care Services (DHCS) in reporting required data to the state. For FY 24-25, the fee was \$18,000, and in FY 23-24 the fee was \$16,000. No other fiscal information found beyond FY 23-24. GL# is 228.90.2520.619.250.
