BACKGROUND/SUMMARY:

The board approved \$755,000.00 in appropriations and developer reimbursement revenue for the 129/Seale Road development project in FY 2023-24. The 129/Searle Rd. development project will not need most of this approved appropriations. The request is to re-allocate \$112,000.00 of expenditures and developer cost reimbursement revenue from the 129/Searle Road development project to other land development projects as follows: 1) Vista Del Calabria \$60,000; 2) Promontory Ridgemark \$10,000.00; 3) Angels Ridgemark \$34,000.00; and 4) Travelers Station \$8,000.00. Costs for all projects will be reimbursed by billings to the developers.
