**BACKGROUND/SUMMARY:**

As required by State law, Government Code Section 65400 and 65700 mandates that all cities and counties submit an annual report on the status of the General Plan and progress in its implementation to their legislative bodies, the Governor's Office of Planning and Research (OPR) and the Housing and Community Development (HCD) by April 1 of each year. An annual report must be submitted to the Governor's Office of Planning and Research (OPR), identifying the progress made with the General Plan implementation. The 2025 General Plan Annual Progress Report (APR) identifies the actions undertaken by San Benito County in the previous calendar year to carry out the 2035 General Plan's implementation programs. This is to report what was accomplished within the calendar year of 2025 of the County's progress and implementation of the 2035 San Benito County General Plan. Then 2025 General Plan Annual Progress Report was reviewed by the San Benito County Planning Commission at its regular meeting of Wednesday, February 18, 2026 and recommended to the San Benito County Board of Supervisors.
