BACKGROUND/SUMMARY:

County staff have maintained a list of board-requested items since 2022 and have updated the list as appropriate. The list has routinely been attached to each respective Board agenda for viewing by board members and the public. In 2023, the board requested items totaling 111, with 99 items being completed by December 31, 2023.

The Board has previously discussed future agenda items and reached a consensus in streamlining the process to maximize efficiency and completion of requested items. The County Clerk of the Board has contacted the California Clerk of the Board Association and obtained other county jurisdiction process examples including Tuolumne and Fresno County.

Per the County of Fresno's Management Directives 2300, section "2314 - Items by Board Members," Board Members may place any agenda item on the Board's agenda with the CAO's advance knowledge and approval. Each Supervisor shall be limited to no more than two items on the Regular agenda at a single regular Board meeting, unless the Board directs otherwise. However, this limitation shall not apply

to proclamations, if placed on the Consent calendar, and adjournments in memory of a person, which shall always be placed on the Consent calendar.
