**BACKGROUND/SUMMARY:**

This proposed contract amendment updates the scope of work, budget detail and payment provisions and additional provisions of the original contract agreement to provide mental health services funding for the term of July 1, 2022, to June 30, 2027. The contract total remains unchanged.

In order to comply with the provision of required community mental health services funding and to also ensure the maintenance of matching funds required for a substantial portion of the Behavioral Health Department's Medi-Cal services revenue paid to the County, this contract amendment is required to be approved for enactment by the County. This agreement also is inclusive of the terms and conditions for the County to access MHSA (Mental Health Services Act- Prop 63) funds. This Agreement, which is the County Behavioral Health Department's performance contract, as required by Welfare and Institutions Code (W&I) sections 5650(a), 5847, and Title 9, California Code of Regulations (CCR), section 3310, sets forth conditions and requirements that the County must meet in order to receive this funding.
