BACKGROUND/SUMMARY:

State of California Department of Housing and Community Development Transitional Housing Program (THP) 1 issued an allocation acceptance form, dated November 1, 2022, under Round 4 has provided HHSA Protective Services division an opportunity to opt in to receive funding between \$16,650 to \$33,300 to assist youth ages 18 to 24 years, formerly in foster care and youth formerly in the probation systems who are homeless or at risk of becoming homeless with housing assistance.

Funds shall be used to help youth, inclusive, secure and maintain housing with priority given to youth formerly in the state's foster care of probation systems. Use of funds may include, but are not limited to:

- 1. Identify and assist housing services for this population in San Benito County
- 2. Assist this population to secure and maintain housing
- 3. Improve coordination of services and linkages to community resources within the child welfare system and the Homeless Continuum of Care; and
- 4. Provide engagement in outreach and targeting to serve those with the most severe needs.
