Approve Amendment #1 with Kings View for Telepsychiatry services to increase FY24-25 contract budget amount by \$21,896.00 for an amount not to exceed \$71,896.00 to cover underestimated funds due to primarily the increase of minimum hours worked by the contractor's providers as the fee-for-service telepsychiatry services transitioned from one telepsychiatrist to another, and authorize Chair to sign.

**BACKGROUND/SUMMARY:**

Kings View has been providing telepsychiatry doctors for over ten years to San Benito County Behavioral Health. The contract amounts have increased and decreased every year per the anticipated service needs for medication support clients. For FY24-25, SBCBH underestimated the budget amount needed to cover the actual service needs, and thus requesting an increase of an additional \$21,896. The current telepsychiatrist provided by the contractor serves about 60 clients. The increase in costs is attributed to the rate increase between FY23/24 and FY24/25 as well as the increase of minimum hours worked by the contractor's providers as the services transitioned from one telepsychiatrist to another.

Fiscal year-to-date (from July 2024 to February 2025), the actual costs total \$47,656.

Amendment needs to cover \$21,896.00 remaining estimated year-to-date costs for March 2025 through June 2025 as follows:

\*Unpaid March invoice of \$5,152 due to it going over the FY24-25 contract budget

\*Anticipated April cost  $\$322 \times (5 \text{ weeks}; 4\text{hrs/week}=20) = \$6,440$

\*Anticipated May cost  $\$322 \times (4 \text{ weeks}; 4\text{hrs/week}=16) = \$5,152$

\*Anticipated June cost  $\$322 \times (4 \text{ weeks}; 4\text{hrs/week}=16) = \$5,152$

\*Invoices are based on hours spent by provider: 4hr shifts weekly at \$322.00/hour (average invoice cost has been \$5,152.00/month).
