BACKGROUND/SUMMARY:

The Board adopted an ordinance on August 27, 2024 addressing use of public right of ways in the County. However, a pre-existing ordinance existed as land within the San Benito River Area. That ordinance may remain, but these changes allow it to be more easily enforced, and make it consistent with Ordinance 1067, adopted August 2024. Additional minor changes have been made in Ordinance 1067, and also to specify that Ordinance 1067 will be codified (included in the San Benito County Code.)

This ordinance was introduced at the November 12, 2024 meeting.
