BACKGROUND/SUMMARY:

Various road projects were budgeted this year to be financed through the Regional Surface Transportation Program (RSTP) funds the County receives. The RSTP funds were to be transferred to the road divisions incurring the road costs. However approximately \$1,400,000.00 for an approved road striping project was paid directly to contractors out of the RSTP program, resulting in a mismatch between the account the payments were originally budgeted in and the actual accounts that were used to record the contractor invoices. Accounting policy requires that there be approved appropriations budget in the account that was used to record the payments. This budget adjustment transfers the budget to the account used to record the payments from the budgeted account. No additional cost is incurred as this is a transfer or reclassification of approved budget appropriations.
