Approve ratification of single case agreement with Discovery Behavioral Health for Residential Treatment eating disorder services beginning 12/1/22 through 01/15/2023 in an amount not to exceed \$75,000.00 and authorize the County Administrative Officer to sign subsequent amendments up to \$50,000.00, consistent with each agreement's subject matter and scope of work and with County Counsel concurrence.

BACKGROUND/SUMMARY:

The State Department of Health Care Services (DHCS), through the 1915 B waiver process with the Federal Centers for Medicare and Medi-Caid Services, requires local county Mental Health Plans to provide an array of services for Medi-Cal beneficiaries. These include inpatient, residential, and intensive outpatient services to address a variety of conditions including eating disorders. Eating disorders are highly complex conditions with both psychiatric and medical components, and the inpatient and outpatient facilities normally contracted with by the Behavioral Health Department do not address this specialized need, especially for youth clients. This requires San Benito County to enter into single case agreements, often at a very accelerated timeline, to ensure both the psychiatric, and medical components are addressed in a crisis situation.

San Benito County has one youth under the age of 18 who is in dire need of this specialized service at

the residential treatment level at this time requiring a single care agreement.

Discovery Behavioral Health is a provider of the specialized eating disorders services at the Residential Treatment level, more specifically for youth populations. The services are evidence based, trauma informed, and outcomes driven. It includes a focus on the whole family as it is often within the family setting that these medically and psychologically complex eating disorders will need to be addressed over time, especially for adolescents. One single case agreement is needed for this placement.

Behavioral Health is currently negotiating a contract with Discovery Behavioral Health, but due to the immediate and dire need of the client, a single case agreement was necessary to obtain the necessary treatment
