Approve the Memorandum of Understanding (MOU) between the San Benito County Probation Department and the San Benito County Office of Education (SBCOE) to provide a coordinated approach from both agencies to closely monitor and supervise juvenile probationers at the San Andreas High School, San Benito County Opportunity School, and Pinnacles Community School sites for the term of November 1, 2024, through November 30, 2026, to be funded by the 2011 Public Safety Realignment Grant AB 109 in the amount of \$38,700.00 per fiscal year for a total two-year contract amount of \$77,400.00.

BACKGROUND/SUMMARY:

This Memorandum of Understanding (MOU) was developed and entered into by the San Benito County Probation Department, hereafter known as SBCPD, and the San Benito County Office of Education, hereafter known as SBCOE. The collaboration between the probation officer and school staff will be evident to all students, but especially students who may need additional support as they transition off of formal probation.

The Deputy Probation Officer will develop school-based intervention options, such as community service or other prosocial activities, designed to hold youth accountable for misconduct and prevent further entry into the juvenile justice system.

The Deputy Probation Officer duties include but are not limited to the following:

- 1. Provide supportive services to SBCOE in the area of delinquency prevention and diversion.
- 2. Serve as a resource to SBCOE regarding dispositional options and to assist the school in making appropriate referrals to collateral agencies or other components of the juvenile system.
- 3. Develop school-based intervention options, such as community service or other prosocial activities, designed to hold youth accountable for misconduct and prevent further entry into the juvenile justice system.

The purpose of this agreement is to provide a coordinated approach, utilizing available resources from both agencies, to closely monitor and supervise juvenile probationers, and assist with at-risk students within the school system. Both agencies believe that the addition of a campus-based probation officer will further this goal and agree to collaborate by coordinating and providing an array of services. The MOU offsets general funds by utilizing the 2011 Public Safety Realignment Grant towards the salary of the Deputy Probation Officer.
