**BACKGROUND/SUMMARY:**

San Benito County Behavioral Health has been providing prevention and education services to youth in the Hollister School District since 2020. The Behavioral Health Department works with the students ages 5 to 14 years old to develop skills that lead to improved emotional well-being and positive behaviors. These services include classroom presentations, individual support and subject specific groups focused on prevention. These programs serve 800-1000 students annually.

This is the first formal memorandum of understanding with the school district in accordance with the new San Benito County purchasing policy. This MOU is dated retroactively to the start of the school year.

**FISCAL IMPACT:**

This MOU has no financial component.
