BACKGROUND/SUMMARY:

The County of San Benito has an existing agreement for legal services from Hefner, Stark, and Marois, LLP. This contract is for legal services relating to complex land use legal matters and CEQA review; costs are recovered where able, such as by permit applicant (Waste Solutions Group of San Benito County). Costs to cover sanitary ad hoc work is not reimbursable, and is funded by Integrated Waste Management's Landfill fund. This contract is also for services related to landfill contract negotiation, and these costs are borne by the County. This amendment will increase the contract by an additional \$150,000.00.

RFP AND BID HISTORY:

The County engaged Hefner, Stark, and Marois, LLP for specialized legal services in Land Use law based on their expertise and prior experience. Breann Moebius, formerly a deputy county counsel with El Dorado County, brought extensive knowledge in land use, planning, public works, and CEQA law and had previously served as a contracted backfill Deputy County Counsel for San Benito in early 2022. The County initially contracted with Hefner on January 10, 2022, for \$50,000. The contract has been amended five times, with the latest extension through June 1, 2025, without an increase in the contract amount.
