Background:

Beginning in June of 2023, Facilities staff responded numerous times to a failed air conditioning system at Fire Station #61. Staff worked with a vendor for repair of the specialized existing Daikin units for months without successful resolution.

The Fire Department crews, which occupy the station through twenty-four-hour shifts, endured numerous "temporary" solutions, none of which adequately cooled the entire firehouse. As a result, these crews were forced to temporarily relocate for a portion of this time.

Following the City's Purchasing Policy, staff obtained three (3) quotes, which are included in "Attachment A" - Emergency Replacement Justification Memorandum, provided to the City Manager on August 8. 2023, requesting the issuance of an Emergency Purchase Order (PO) for the replacement Air Conditioning (A/C) units.

United Air Conditioning of Largo, FL, was issued a PO in the total amount of \$54, 440.66 for the replacement of the aforementioned A/C System at Fire Station #61, located at 903 Michigan. Although United Air Conditioning was not the lowest bid (by approximately \$1000), they were able to begin the A/C replacement work immediately, as they had the units in stock. This work has been completed and the system is functioning well.

This unplanned, unbudgeted expense will be charged to Citywide HVAC Replacements, Project #64801, Acct #001-2220-522-054610-PS. As mentioned in the "Budget Impact" section of this memorandum, this transaction requires a Budget Adjustment / Transfer, which will be brought before the Commission for approval at a future Quarterly Budget Update.

In order to comply with the City's Purchasing Policy and given these costs exceeded the City Manager's Delegated Authority threshold of \$50,000, staff hereby requests the Commission ratify the emergency actions described herein.
