Background: The City of Dunedin's Five EPIC! Goals were originally established by the

City Commission in 2018 at the Strategic Planning Session. In 2020, the

Commission proposed a Sixth EPIC! Goal in order to focus on City Employees and the City as a workplace environment. This additional goal allows the City Employees to be extracted from the fifth and addressed separately. These goals are the bedrock of an innovative Strategic Plan that better reflects the objectives of the City Commission for moving the City forward.

The Business Plan is the roadmap by which the organization can accomplish the six EPIC! Goals. The plan's initiatives and projects provide a clarity of purpose and realistic assignments that will guide the day-to-day operations of the City. A funding source (if necessary), timeframe, and goal are identified for each of the projects and initiatives.

The City's Draft FY 2022 – FY 2027 Municipal Business Plan was published May 4, 2021 and presented to City Commission on May 14, 2021 for review and further discussion. The Business Plan includes 58 Business Plan Initiatives and 106 Capital Improvement Projects for a total of 164 items and a total investment of \$101,289,018 during the FY 2022- FY 2027 planning period.

After the City Commission has adopted the Business Plan, it will be deployed throughout the organization and the City's Boards and Advisory Committees so that all who participate in operations within Dunedin are fully cognizant of the strategic direction set by the City Commission.
