Special Event Application and Amplified Sound Permit - Fuquay-Varina Grower's Market - April 2026 - September 2026 - (Famolare) - Item 8.D

Item Explanation

The purpose of this agenda item is to consider approving a Special Event Application and Amplified Sound Permit for the Fuquay-Varina Grower's Market scheduled from April 11, 2026, through September 5, 2026, as presented and recommended.

Staff Comments

The Fuquay-Varina Grower's Market is requesting a Special Event Application and Amplified Sound Permit for the Fuquay-Varina Grower's Market scheduled for April 11, 2026, through September 5, 2026. This event will occur in the Fuquay-Varina Chamber of Commerce parking lot at 121 N. Main Street.

The Fuquay-Varina Growers Market is a 501(c)3 nonprofit organization that cultivates and supports partnerships among local farmers, producers, artisans, and the public. During Spring (April-May), the Growers Market will take place on Saturdays from 9:00 am - 1:00 pm, with event set-up beginning at 8:00 am and breakdown starting at 1:00 pm. During Summer (June - September), the Growers Market will take place on Saturdays from 8:00 am - 12:00 pm, with event set-up beginning at 7:00 am and breakdown starting at 12:00 pm. There may be live music or a music box during the events.

The Fuquay-Varina Growers Market will take place at the Fuquay-Varina Chamber of Commerce's parking lot. 750 attendees are expected per day on average, with four employees. The Fuquay-Varina Chamber of Commerce hosted the Growers Market last year at the event's proposed location. The Growers Market event intends to utilize visitor parking on Town-owned property for which appropriate insurance has been provided. An updated Certificate of Insurance is expected to be provided by the Growers Market by the end of June 2026. The Growers Market event organizers have been informed that the updated Certificate of Insurance is necessary to continue using town property for event parking and have also been informed that town property for event parking will be evaluated on a year-by-year basis given the Town has plans to eventually improve the town property for park and town event space.

The Town Manager, Public Works Director, Fire Chief, Planning Director, and Police Chief

have reviewed the Special Event Application and Amplified Sound Permit and recommended approval of this event.
