AGENDA LANGUAGE:	Authorize the issuance of a purchase order to FieldTurf USE, Inc. (Tarkett Sports) utilizing a Cooperative Purchasing Exemption (Sourcewell Contract) in the amount of \$80,301 to furnish and install the Tarkett Restart Overpour System at the Selden Park gymnasium with funding to be provided by the FY25 Facilities Fund. (L. Gurganus) (FC 3-0)
BACKGROUND:	Funds were approved in the FY25 Facilities Fund budget to replace the gym floor at Selden Park. Glynn County Recreation and Parks Department is seeking Board of Commissioners approval to execute the Sourcewell Contract #031022-FTU and issue a Purchase Order to furnish and install a Tarkett Restart Overpour System at the Selden Park gymnasium. The project includes abrading the entire gym floor surface for urethane lift, repairing minor cuts and blemishes, cleaning the surface, applying 2mm urethane resin, applying a topcoat (color to be selected by the County), and applying game lines per existing layout. The price includes one (1) single color logo within center court circle of the main basketball court. This type of flooring system is most highly recommended for a multi-use facility like Selden Park. The gymnasium is used not only for basketball and volleyball. It is also used as a voting precinct, as

an emergency shelter, for private rentals (wedding receptions, birthday parties, family reunions, etc.), health fairs, and more. Due to department programs, facility rentals, and voting scheduled from now through February, the project will begin in March. The project is expected to take 30 - 45 days from start to completion. The vendor will provide a detailed maintenance plan for daily, monthly, and annual care of the new floor.

Per the County's Procurement Ordinance, the Procurement Officer has reviewed the Sourcewell contract documents and supports utilizing this Cooperative Purchasing Contract for this project.

1. Authorize issuance of a Purchase Order to FieldTurf USE, Inc. (Tarkett Sports) to furnish and install a new gym floor at Selden Park
2. Suggest other alternatives
