- AGENDA LANGUAGE:** Approve the Memorandum of Agreement between the Georgia Department of Transportation (GDOT) and Glynn County for Right-of-Way acquisition for PI No. 0014914, CR 583/Sea Island Road at Dunbar Creek on St. Simons Island, as part of the Statewide Transportation Improvement Plan. Glynn County will contribute \$160,000 to the Right-of-Way acquisition, with funding provided by the Capital Projects Multi-Year Fund balance. (D. Smith)
- BACKGROUND:** GDOT has added PI No. 0014914 CR 583/Sea Island Road @ Dunbar Creek on St Simons Island to the Statewide Transportation Improvement Plan and has agreed to administer the project to perform the functions required for the successful completion of ROW Acquisition necessary to replace the bridge over Dunbar Creek.
- Glynn County has agreed to contribute funding towards expenses associated with the acquisition of right-of-way for the bridge replacement project. The ROW Acquisition funds contributed by Glynn County will be used to fund ROW Acquisition costs, staff hours, and any other associated expenses incurred by GDOT. The estimated amount for the ROW Acquisition funding is one hundred and sixty thousand and 00/100 (\$160,000.00).
- Glynn County has agreed to pay the amount of one hundred and sixty thousand and 00/100 (\$160,000.00) to GDOT within thirty (30)

days of the effective date of this Agreement for Right of Way Acquisition as a Local Match for the Bridge Replacement Project. The Local Match will be used towards expenses incurred by the GDOT for activities associated with ROW Acquisition services for the project, including staff hours and any other associated expenses.

Upon project completion, Glynn County shall assume responsibility for and bear all costs and liability associated with the ongoing maintenance of the ROW within the project limits.
