# **RECOMMENDED ACTION**

Staff recommends that the Commission for the Arts determine what information they would like to present to the City Council for the Commission's Annual Update on April 14, 2025.

## **SUMMARY**

The Commission for the Arts is scheduled to make a brief presentation to the City Council at their City Council Meeting on April 14, 2025, at 7:00 p.m. This presentation should include an overview of Commission responsibilities as well as activities over the past year.

#### DISCUSSION

Each City of Livermore Board, Commission, and Committee is required to make an annual presentation to the City Council. This presentation should be a brief, five minute overview of the work done by the Commission for the Arts during the past year. While the presentation should focus on the efforts and accomplishments of the Commission and its members, it can also include any other matters that the Council should be aware of. This presentation is currently scheduled for the City Council Meeting on April 14, 2025, at 7:00 p.m. The Commission Chair generally delivers the presentation, but the Vice Chair or another commissioner can give the presentation if the Chair is not available on the scheduled date.
