**SUBJECT:** Resolution authorizing the issuance of a purchase order for the replacement P-25 radio

equipment from Motorola Solutions for emergency radio communications through the

East Bay Regional Communication System (EBRCSA).

#### **RECOMMENDED ACTION**

Staff recommends the City Council adopt a resolution authorizing the issuance of a purchase order with Motorola Solutions in an amount not-to-exceed \$1,448,055 for the purchase and delivery of P-25 radio equipment.

#### **SUMMARY**

Staff recommends the purchase and delivery of replacement radio equipment from Motorola Solutions. The current radios are at end of life and are in need of new encryption software.

#### DISCUSSION

On July 23, 2007, the City Council passed and adopted Resolution No. 2007-167. This resolution allowed the City of Livermore to participate in the development of a regional communication system serving Alameda and Contra Costa Counties. The City became a part of the East Bay Regional Communication System (EBRCS) at that time. In June 2009, the East Bay Regional Communication System Authority (EBRCSA) entered into an agreement with the City to install equipment that would support a new interoperable radio system. The current mobile and portable radio equipment was purchased in 2012 and is now at end of life and needs to be replaced.

The 2025 Motorola Solutions Customer Agreement (MCA) between Motorola Solutions and the Contra Costa County under Section 1.1.2. Eligible Purchases allows other local government agencies as well as third party service providers that use the EBRCSA System as Eligible Purchasers, and they may execute individual purchase orders with Motorola referencing this MCA for receiving and accepting the products and services outlined in this MCA. Section 2.68.370 of the Municipal Code provides that supplies and equipment may be purchased without conducting informal solicitation or competitive bidding when the procurement is based on cooperative purchasing arrangements or programs entered into by any public

agency or agencies situated within the state, regardless of whether the City is a named party to such an agreement or an actual participant in such a program.

## FISCAL AND ADMINISTRATIVE IMPACTS

The funds for the radio replacement have been allocated in the City's CIP Project PS202716. There is sufficient funding available in the CIP during FY 2025-26 for the purchase of the replacement radios and encryption keys.
