Purchase of three (3) Portable Generators

Summary:

Requesting authorization and approval of the following:

Authorization and approval of a competitive procurement exemption pursuant City Code Sec. 2-226(g)(5).

Authorization and approval to issue a purchase order and process payment(s) to Federal Contracts LLC dba Federal Contracts Company for the purchase of three (3) "Portable Generators" utilizing the pricing structure identified in Florida Sheriff's Contract No. FSA23-EQU21.0 for an amount of \$213,651.30.

Procurement:

Notwithstanding the obvious benefit and public interest served by having all purchases submitted to competitive procurement, circumstances can arise when the City may determine that there is no need for the City to seek competitive procurement.

The Utilities and Procurement Departments are requesting a competitive procurement exemption pursuant to Sec. 2-226(g)(5) of the City's code, where it states this action may be utilized if purchases are based upon prices from contracts executed within the preceding eighteen (18) months of the contemplated purchase by the state, a state agency or district, a county or municipal corporations within the state, including the city, which contracts were based upon an advertised competitive bid or proposal process, and which purchases use city approved forms or contract documents.

The use of the "FSA" Contract No. FSA23-EQU21.0 complies with the City of Plantation Code Sec. 2-226(g)(5); the contract is currently set to expire September 30, 2026.

Based on the foregoing, Utilities and Procurement Departments requests authorization and

approval of the following:

- Authorization and approval of a competitive procurement exemption pursuant City Code Sec. 2-226(g)(5).

Background:

Strategic Priorities: Proactive and Responsive Asset Management

Utilities has budgeted (3) Portable Generators per fiscal year to replace/upgrade aging generators currently in the fleet that are no longer cost effective to repair/maintain. Portable Generators are used to power lift stations and equipment to keep sanitary systems running during emergency events or power failures.
