Subject:

Agreement No. 045-22; Supply and Delivery of Badger Meters and Accessories with Cellular Solutions- Badger Meters Inc. (Amendment No. 4)

Summary:

Requesting authorization and approval of the following:

To execute the fourth (4th) Amendment between the City of Plantation and Badger Meter, Inc., for Supply and Delivery of Badger Meters and Accessories with Cellular Solutions, associated with Agreement No. 045-22; to include a price increase (See Exhibit A of the attached Amendment); and extending/renewing this Agreement for an additional one (1) year period pursuant to Section 3 (Term) of the executed Agreement until May 31, 2027.

To continue issuing purchase order(s) and process payment(s) to Badger Meter, Inc., for Supply and Delivery of Badger Meters and Accessories with Cellular Solutions in accordance with Agreement No. 045-22.

Procurement:

Agreement No. 045-22; Badger Meters and Accessories with Cellular Solutions is currently set to expire May 31, 2026. The Agreement contains a provision for four (4) additional one (1) year renewal/extension options, provided the Contractor also agrees in writing to extension upon such terms as the City and Contractor agree. This would be the fourth (4th) and final allowable one (1) year renewal/extension option.

The Utilities Department has determined that the Contractor has performed in accordance with the requirements of the Agreement and wishes to extend the agreement pursuant to Section 3 (Term) of the agreement. Badger has also requested a price increase, based on the Consumer Price Index for All Urban Consumers as reported by the U.S. Bureau of Labor Statistics of the U.S. Department of Labor from March 2025 - February 2026. The Utilities Department and concluded the proposed price increase was fair and reasonable. The

Procurement Department negotiated a reduced percentage increase.

- Badger Meter originally requested a 4% price increase. After some diligence, research and open conversation both Parties agreed to a 3% increase. This decision was based on the following:
 - Current CPI (3.1%) and PPI (4.0%) data from March 2025 to March 2026 which averaged to 3.5%, and noting the previous adjustments of 3.091% and 2.16% in Amendments 2 and 3.

Based on the foregoing information, the Utilities and Procurement Departments requests authorization and approval of the following:

- To execute the fourth Amendment between the City of Plantation and Badger Meter, Inc., for Supply and Delivery of Badger Meters and Accessories with Cellular Solutions, associated with Agreement No. 045-22; to include a price increase (See Exhibit A of the attached Amendment); and extending/renewing this Agreement for an additional one (1) year period pursuant to Section 3 (Term) of the executed Agreement until May 31, 2027.
- To continue issuing purchase order(s) and process payment(s) to Badger Meter, Inc., for Supply and Delivery of Badger Meters and Accessories with Cellular Solutions in accordance with Agreement No. 045-22.
