# Subject:

WB No. 036-25; Breaker Testing and Repairs

# **Summary:**

Request for authorization and approval of the following:

Authorization and approval to issue a purchase order and process payment(s) to LND Technical Services, LLC. for "Breaker Testing and Repairs" in accordance with WB No. 036-25, for an amount of \$59,000.00.

#### **Procurement:**

Pursuant to City Code Sec 2-226(b) the Procurement Department secured informal competitive bids for the mentioned services/work. On July 22, 2025 six (6) competitive bids were received. This solicitation was advertised/posted on the Demand Star website for thirty-two (32) calendar days. This solicitation was broadcasted to 2072 suppliers/vendors and had 32 Planholders. A copy of the six (6) competitive bids are attached for your review.

**Note:** After the public release of the solicitation, the Procurement Department asked the Utilities Department to inform any vendors/contractors known to them of this opportunity.

Lastly, no local (City of Plantation) businesses submitted a bid.

The Procurement Department staff performed a review of the apparent low bidder (LND Technical Services, LLC) to ascertain submittal responsiveness. After careful consideration of all the information provided by the bidder, the Procurement Department staff concluded LND Technical Services, LLC (apparent low bidder) submitted the lowest, responsive bid submittal.

The Utilities Department staff performed a review of the lowest responsive bid(der) to ascertain if they were responsible. After careful consideration of all the information provided, the Utilities Department staff has concluded that LND Technical Services, LLC has submitted the lowest responsible bid.

Based on the foregoing, Procurement and Utilities Departments requests authorization and approval of the following:

 Authorization and approval to issue a purchase order and process payment(s) to LND Technical Services, LLC. for "Breaker Testing and Repairs" in accordance with WB No. 036-25, for an amount of \$59,000.00.
