Summary:

Requesting authorization and approval of the following:

Authorization and approval to waive the procurement requirement detailed in section 2-226(b) of the City's code relating to the advertising/posting an informal bid/proposal via the internet for three (3) complete working days.

Authorization and approval to issue a purchase order and process payment(s) to SHI International Corp., for "Renewal of Security Software" for the amount of \$41,347.97.

Procurement:

Due to the sensitive nature of the requested services, the City found it prudent and in its best interest to request informal competitive quotes from known sources/vendors rather than publicly soliciting for mentioned services. It is for this reason why we are requesting to waive the procurement requirement detailed in section 2-226(b) of the City's code relating *advertising/posting an informal bid/proposal via the internet for three (3) complete working days.*

The Information Technology and Procurement Department seek authorization and approval to issue a purchase order and process payment(s) to SHI International Corp., for "Renewal of Security Software". The IT Department informally solicited quotes from three (3) vendors as follows:

Background:

Strategic Priorities: Quality Customer Care; and Sustainability.

Renewal of this platform is critical to maintaining the City's ability to monitor, detect, and respond to data security threats in real time. The software delivers deep visibility into file access patterns, user behavior, and permission structures across our network, helping the IT Department proactively identify insider threats, excessive user privileges, and abnormal data activity. Since its deployment, the software has proven essential in reducing exposure risks by flagging over-permissioned accounts, mass file movements, and off-hours access—events that often precede ransomware or data loss incidents. Its auditing capabilities support compliance with regulatory requirements (such as CJIS and HIPAA) and ensure accountability through detailed activity logs and automated alerting. The software also enables automated remediation and streamlines policy enforcement across Active Directory and our shared file systems. This renewal will preserve our access to these core capabilities and allow the City to continue maintaining a secure, compliant, and well-governed digital environment.
