Agreement No. 065-25; Independence Day Fireworks- Term Agreement

Summary:

Requesting authorization and approval of the following:

- Authorization and approval to execute an Agreement (see attached) between the City of Plantation and Zambelli Fireworks MFG. Co. for "Independence Day Fireworks" in accordance with RFIP No. 065-25 for a term of two (2) years.
- Authorization and approval to issue purchase order(s)/task order(s) and process payments to Zambelli Fireworks MFG. Co. for services described and in accordance with the attached agreement (065-25).

Procurement:

The City publicly solicited for qualified Firms pursuant to Sec. 2-226(b) of the City's Code, for "Independence Day Fireworks" (RFIP No. 065-25). On October 14, 2025, the City received one (1) proposal. The RFIP was advertised/posted on the Demand Star website for thirty-nine (39) calendar days. This solicitation was broadcasted to 135 suppliers/firms and had eleven (11) Planholders.

The Procurement Department performed a review of the bid submittal to ascertain if it was responsive. The sole bid received was determined to be responsive and was subsequently approved for Selection Committee review and scoring /ranking. The Selection Committee held a public meeting on January 20, 2026 @2:00pm to discuss and potentially score the submitted proposal pursuant to the advertised evaluation criteria.
