**Subject:**

ITB No. 049-25; Reuse Filter Media Replacement

**Summary:**

Requesting authorization and approval of the following:

Authorization and approval to issue purchase order(s) and process payment(s) to C & C Environmental Services, Inc., for "Reuse Filter Media Replacement " in accordance with ITB No. 049-25 for an amount not to exceed \$242,000.00.

**Procurement:**

Pursuant to City Code Sec. 2-220(e) the Procurement Department secured formal competitive bids for the above-mentioned services. On August 19, 2025, there were a total of thirty-one (31) planholders for this solicitation and five (5) competitive bids were received. One (1) competitive bid was deemed non-responsive, the vendor failed to upload bid documents. This solicitation was advertised/posted on the Demand Star website for fifty-three (53) calendar days and broadcasted to 668 suppliers. A copy of the four (4) competitive bids are attached for your review.

The numerical results are as followed:

The Procurement Department staff performed a review of the apparent low bidder (C & C Environmental Services, Inc.) to ascertain submittal responsiveness. After careful consideration of all the information provided by the bidder, the Procurement Department staff concluded C & C Environmental Services, Inc. (apparent low bidder) submitted the lowest, responsive bid submittal.

The Utilities Department staff performed a review of the lowest responsive bid(der) to ascertain if they were responsible. After careful consideration of all the information provided, the Utilities Department staff has concluded that C & C Environmental Services, Inc. has submitted the lowest responsible bid.

Based upon the foregoing information, the Utilities and Procurement Departments requests authorization and approval of the following:

- Authorization and approval to issue purchase order(s) and process payment(s) to C & C Environmental Services, Inc., for "Reuse Filter Media Replacement " in accordance with ITB No. 049-25 for an amount not to exceed \$242,000.00.

**Background:**

**Strategic Priorities: Planning for a Sustainable Future, Proactive and Responsive Asset Management**

Filter media requires replacement every 5 - 6 years for proper operation of the reuse filters at the Regional Wastewater Plant. The reuse filters provide final filtration of plant effluent water to provide reuse water for plant operation process and onsite irrigation.

This item is now ready for City Council consideration.
