Authorization and approval to execute a purchase order and process payment(s) to Sport Surfaces LLC, for "Resurfacing of Tennis Courts at the Plantation Community Center (3 East Courts and 3 West Courts)" in the amount of \$54,400.00 (see attached quote for additional details).

**Procurement:**

The Parks and Recreation and Procurement Departments seek authorization and approval to issue a purchase order and process payment(s) to Greyson Technologies, Inc., for "Resurfacing of Tennis Courts at the Plantation Community Center (3 East Courts and 3 West Courts) The Parks and Recreation Department informally solicited quotes from four (4) vendors for the mentioned work.

Due to the time that would be needed to pursue the standard procurement process for this project, the City felt it was in its best interest to waive the procurement requirement detailed in section 2- 226(b) of the City's code relating to internet posting, and sought informal quotes from known sources/vendors so to expedite the completion of this project while attempting to avoid any safety concerns and funding (grant) losses with other project(s) associated with the timely completion of this project.

Life span of courts are 5 - 7 years. Failure to resurface these courts within that timeframe results in hazardous playing conditions and potentially failure to the sub-base resulting in more costly repairs.
