Subject:

Agreement No. 072-22; Asphalt Rejuvenation Project - Term Contract (Amendment No. 3)

Summary:

Request for authorization and approval of the following:

- Authorization and approval to execute the Third Amendment between the City of Plantation and Pavement Technology, Inc., for "Asphalt Rejuvenation- Term Contract" Agreement No. 072-22, providing for a rate increase and extending/renewing this Agreement for an additional one (1) year period pursuant to Section 3 (Term) of the executed agreement (see attached) until April 16, 2027.
- Authorization and approval to continue issue purchase order(s) and process payment(s) to Pavement Technology, Inc., for "Asphalt Rejuvenation- Term Contract", in accordance with Agreement No. 072-22.

Procurement:

The Agreement No. 072-22; Asphalt Rejuvenation - Term Contract, is currently set to expire April 16, 2026. The original agreement contains a provision for four (4) additional one (1) year renewal/extension options, provided the Contractor also agrees in writing to extension upon such terms as the City and Contractor agree. This would be the third (3rd) of four (4) allowable one (1) year renewal/extension options.

The Public Works Department has determined that the Contractor has performed in accordance with the requirements of the Agreement and wishes to extend the agreement for a third time pursuant to Section 3 (Term) of the Agreement. Pavement Technology, Inc. has also requested a price increase which is reflected below:

Background:

Strategic Priorities: Quality Customer Service; Sustainability; Quality of Life.

To continue installing Reclamite to roadways to prolong the life-expectancy. Reclamite works by rejuvenating the asphalt binder and sealer to the existing roadway to prevent water intrusion. This type of installation is encouraged by the Federal Highway Administration. This product needs to be installed while the current pavement is in good condition.

This item is now ready for City Council consideration.

Funding:

No Financial Impact at this time. The use of this term contract is based on Departmental need and the availability of budgeted funds.

Amount:

Base Bid A: (Primary Product) Standard Specification- Reclamite

- ~~\$1.24/ per square yard~~ **\$1.27/per square yard.**

Base Bid B: (Secondary Product) Bid Alternate #1 (Pollution-Remediating Maltene Asphalt Rejuvenator)

- ~~\$2.49/per square yard~~ **\$2.60/per square yard.**

This agreement is based on the Department needs and available funding for this type of work.
