Subject:

Purchase of Police Ammunition (SWAT Training and Duty Use)

Summary:

Request for authorization and approval of the following:

- Authorization and approval of a competitive procurement exemption pursuant to Sec. 2-226(g)(3) of the City's Code.
- Authorization and approval to issue a purchase order and process payment(s) to Florida Bullet Incorporated for the purchase of Police Ammunition (SWAT Training and Duty) as further detailed in the attached quote for a total amount of \$75,541.70.
- Authorization and approval of a Liftgate and/or inside delivery contingency for an amount not to exceed \$1,000.00. Actual amount, if applicable shall be paid to Florida Bullet Incorporated.

Procurement:

On October 23, 2023, in accordance with Florida Statute 287.057(3)(c), the Procurement Department electronically advertised an Intent to Sole/Single Source (ISS No. 004-24) for the supply and delivery of CCI Speer and Federal Cartridge ammunition products for law enforcement purposes. No responses were received in response to the electronically advertised Intent to Sole/Single Source posting. As a result, Florida Bullet Incorporated has been identified as the sole/single provider for the specified ammunition products.

The Intent to Sole/Single Source notice was posted electronically for a period of 15 calendar days, distributed to 97 suppliers, and resulted in eight (8) planholders. The sole/single source designation will remain valid through November 7, 2026, unless another contractor or vendor

submits sufficient documentation demonstrating their ability to provide the originally specified products or services.

Based on the foregoing information, the Police and Procurement Departments request authorization and approval for the following:

- Authorization and approval of a competitive procurement exemption pursuant to Sec. 2-226(g)(3) of the City's Code.
