#### **Summary:**

Request authorization and approval of the following:

 Authorization and approval to issue a work authorization/purchase order and process payment(s) to Craven Thompson & Associates, Inc for Professional Engineering Services (further defined in the attached proposal) associated with the "Old Plantation Water Control District's (OPWCD) Force Main Installation Proj. #1044" in accordance with Agreement No. 015-19; Continuing Consulting Engineering Services for Wastewater and Water Utilities Engineering within Environmental and Sanitary Disciplines (Scope "B" Local/Regional) in the amount of \$175,528.48.

#### **Procurement:**

The Procurement Department has reviewed the information provided and has determined; that the hourly rates utilized to determine the totals provided in the proposal are in accordance with Agreement No. 015-19; "Continuing Consulting Engineering Services for Wastewater and Water Utilities Engineering within Environmental and Sanitary Disciplines (Scope "B" Local/Regional)" between the City of Plantation and Craven Thompson & Associates, Inc - (Scope B) Exhibit "C" Billing Rates (see attached latest Amendment).

This continuing agreement (015-19) between the City and Craven Thompson & Associates, Inc. is set to expire January 16, 2026. In addition, the use of this Agreement (Continuing contract" for the mentioned work complies with Florida Statutes 287-055(g) as the proposed construction is estimated not to exceed 7.5 million dollars.

# Strategic Priorities: Planning for a Sustainable Future

Utilities planned for the design and construction of a 12" force main within Old Plantation Water Control District's (OPWCD) right-of-way. Addition of the force main will allow for future development within the northern end of the mid-town district to increase capacity for additional flow. This project was slated for completion during FY27; however, design plans are being required now in order to obtain a licensing agreement with OPWCD. Utilities/City will provide the design plan for the force main allowing developers the ability to move forward with the permitting & installation of the necessary infrastructure.
