ITB No. 050-25 - Armored Car Services

**Summary:**

Request for authorization and approval of the following:

To execute a term agreement between the City of Plantation and IBI International Logistics Inc. for "Armored Car Services" in accordance with ITB No. 050-25. The agreement shall have an initial two (2) year term, with an option to renew/extend for two (2) additional two (2) year renewal periods, provided the Contractor also agrees in writing to extension upon such terms as the City and Contractor agree.

Authorization and approval to issue purchase order(s) and process payment(s) to IBI International Logistics Inc, for "Armored Car Services" in accordance with ITB No. 050-25.

**Procurement:**

Pursuant to City Code Sec. 2-220(e) the Procurement Department secured formal competitive bid(s) for the work/services referenced herein. On August 12, 2025, three (3) competitive bids were received for ITB No. 050-25 - Armored Car Services. This solicitation was publicly posted for thirty-seven (37) calendar days. It was broadcasted to 570 suppliers and had eleven (11) Planholders. Copies of the three (3) competitive bid submittals are attached for your review.
