 To issue a work authorization/purchase order and process payment(s) to Craven Thompson & Associates, Inc for Professional Engineering Services (further defined in the attached proposal) associated with the "NW 65th Ave. Water & Force Main Relocation" in accordance with Agreement No. 015-19; Continuing Consulting Engineering Services for Wastewater and Water Utilities Engineering within Environmental and Sanitary Disciplines (Scope "B" Local/Regional) in the amount of \$109,857.85.

Procurement:

The Procurement Department has reviewed the information provided and has determined; that the hourly rates utilized to determine the totals provided in the proposal are in accordance with Agreement No. 015-19; "Continuing Consulting Engineering Services for Wastewater and Water Utilities Engineering within Environmental and Sanitary Disciplines (Scope "B" Local/Regional)" between the City of Plantation and Craven Thompson & Associates, Inc. - (Scope B) Exhibit "C" Billing Rates (see attached latest Amendment).

This continuing agreement (015-19) between the City and Craven Thompson & Associates, Inc. is set to expire January 16, 2026. In addition, the use of this "continuing contract" for the mentioned work complies with Florida Statutes 287.055(g), as the proposed construction work is estimated (good faith) not to exceed 7.5 million dollars.
