Authorization and approval to issue a purchase order and process payment(s) to Family Ford Inc. dba Hardy Family Ford Inc, for the "Supply & Delivery of 2026 or Newer Ford Vehicles" in accordance with ITB No. 031-26, for a total amount of \$61,213.00 (see attached submittal for additional information).

Authorization and approval to issue a purchase order and process payment(s) to HFWP, Inc. dba Holler Ford, for the "Supply & Delivery of 2026 or newer Ford Vehicles" in accordance with ITB No. 031-26, for a total amount of \$166,705.00 (see attached submittal for additional information).

Procurement:

Pursuant to City Code Sec. 2-220(e) the Procurement Department secured sealed competitive bids for the above-mentioned equipment. On February 17, 2026, three (3) competitive bids were received. This solicitation was advertised/posted on the Demand Star website for twenty-two (22) calendar days, broadcasted to 259 suppliers and had 22 Planholders. In accordance with the solicitation documents and to ensure that the City received the most competitive pricing for each vehicle, the City elected to pursue a multi-award process. Pursuing this process allowed the City to review pricing on a vehicle-by-vehicle basis and apply the City's Local Preference Ordinance (Sec. 2-227) to each vehicle accordingly.

The Procurement Department staff conducted a review of each bidder to determine submittal responsiveness. After careful consideration of the information provided, the Procurement Department concluded that all bidders were responsive. During this review, the Procurement Department also determined which vehicles fell within the 5% threshold that would trigger the City's Local Preference Ordinance. Lastly, the Procurement Department identified the lowest bidder for each vehicle that fell outside the 5% threshold.

The Public Works Department staff performed a review of the responsive bidder(s) to ascertain if they were responsible. After careful consideration of all the information provided, the Public Works Department staff concluded that each bidder has submitted the lowest responsible bid for specific vehicles based on unit costs.
