Subject:

Agreement Consolidation between the City (Police Department) and GovernmentJobs.com, Inc. D/B/A/ NEOGOV and Additional Module Purchase.

Summary:

Requesting authorization and approval of the following:

Authorization and approval to execute (countersign) all document(s) associated with the consolidation of agreements and operate under the single, unified framework of the NEOGOV Services Agreement (the "Agreement") to govern the provision of PowerTime and any future services.

Authorization and approval to process payment(s) to GovernmentJobs.com, Inc d/b/a NEOGOV for the continuation (renewal) for services rendered for the Plantation Police Department, in accordance with the executed agreement and associated addendums.

Authorization and approval to add additional modules/platforms as necessary to continue to assist and improve the Police Department processes in accordance with the executed agreement and associated addendums.

Procurement:

- In 2015, The City of Plantation, on behalf of the Plantation Police Department entered into SAAS Agreement with PowerDMS Inc. subsidiary of NEOGOV.
- The City previously entered into a Web Application Service and Hosting Agreement (the "PlanIt Agreement") with Ragnasoft LLC (D/B/A/ PlanIT Schedule) on May 1, 2021, for the purchase of a product known as PlanIt Schedule.
- In March 2024, NEOGOV acquired PlanIt Schedule, and the PlanIt Schedule product was rebranded as PowerTime.

- An Order Form (Order # Q-241158) was sent to the City of Plantation Police Department to notify them of the product and name change from Plant Schedule to PowerTime.
- The PlanIt Agreement was fulfilled on May 1, 2024, at which point a new term and a new agreement for PowerTime began.
- The attached addendum serves as an acknowledgement that NEOGOV has acquired PlanIt, and that the City's subscription to PowerTime is subject to the terms and conditions outlined in the attached Order Form #Q-241158 and the NEOGOV Services Agreement.
- The parties now wish to consolidate their agreements and operate under the single, unified framework of the NEOGOV Services Agreement (the "Agreement") to govern the provision of PowerTime and any future services.

Due to the consolidation of the agreements, the rendered services aggregately could exceed \$35,000.00 annually, which requires City Council consideration.

Based on the foregoing information, Police and Procurement Department requests authorization and approval of the following:

Background:

The Police Department uses multiple application through the PD specific instance of PowerDMS. The original contract did not include the schedule management system "Planit". PowerDMS acquired the "Planit" software requiring an alignment of all SAAS agreements now owned by PowerDMS, for the PD. Additionally, the PD has found two additional modules to be of value for the hiring and training of all personnel. PowerReady and PowerVetted.

Power Ready is a software for Field Training Officers and Communications Training Officers. PowerVetted is a software tracking program for the tracking and documenting the background process for all PPD new hires.

This item is now ready for City Council consideration.

Finance Director/Budget Manager Recommendation:

The Police Department budgeted a total of \$21,436 in FY2026 for the Power DMS items outlined above.

Per the Police Department the additional funding required (\$12,734) will be transferred from the Police Department budgeted line-item 2nd Dollar Training for SSD Training.
