Procurement:

On June 12, 2024, consent agenda item No. 5, City Council approved the issuance of a Work Authorization/Task Order to Keith and Associates for "Cypress Road from 74th Ave to East Acre Road- Civil Engineering project". Due to the aggregate value of all change order(s) associated with this project, City Council approval is required.

Change Order No. 1 (Approved Administratively):

- Conceptual design layout, survey and safety analysis of the intersection of Cypress Road and N. Fig Tree Lane. Consultant provided two alternatives.
 - \$15,570.00

Change Order No. 2 (Proposed):

• The design of the preferred alternative. Work includes but not limited to ADA/Curb ramps

design, lighting and landscape upgrades at the intersection of Cypress Road & N Fig Tree Lane. Milling and resurfacing of Cypress Road and Fig Tree Lane within the project limit will also be provided.
