**Subject:**

Purchase of Keen Submersible Pumps for Lift Stations No. 11 and 22.

**Summary:**

Requesting authorization and approval of the following:

Authorization and approval to issue a purchase order and process payment(s) to Williamson Pump & Motor for the "Purchase Keen Submersible Pumps for Lift Stations No. 11 and 22" for an amount of \$70,304.00 (see attached quote for additional details).

**Procurement:**

On February 9, 2022, Consent Agenda Item No. 5, the City of Plantation - City Council approved the standardization of the City's Lift Station Pumps to multiple manufacturers listed below:

For Submersible Station(s):

- Hydromatic - 2 HP and under
- Tsurumi and Barnes - 10 HP
- Flygt, Wilo, and Keen - all HP and sizes

For Can Style Station(s):

- Gorman Rupp
- Crown

Pursuant to the "Standardization" requirements, the Utilities Department received competitive informal quotes from the manufacturers listed in the "Notice of Standardization" for submersible stations (all HP and Sizes) for Lift Station No. 11 and 22 by having them bid against each other (see quotes attached from identified distributors for each approved manufacturer).

On February 24, 2025, the City of Plantation posted a Notice to Intent to Sole Source (ISS) on

the website named Demand Star for Genuine Keen pumps, basin packages, controls and control panels, and parts. This notice closed on March 11, 2025 @11:00am and the City of Plantation did not receive any written statements from any other contractors/vendors indicating that they could provide products specified in ISS No. 019-25. The Sole/Single Source was then awarded to Williamson Pump & Motor.

Based on the foregoing information, the Procurement and Utilities Departments are requesting authorization and approval of the following:

- Authorization and approval to issue a purchase order and process payment(s) to Williamson Pump & Motor for the "Purchase Keen Submersible Pumps for Lift Stations No. 11 and 22" for an amount of \$70,304.00 (see attached quote for additional details).
