Subject:

WB No. 054-26; Bus Transportation Services- Term Contract

Summary:

Request for authorization and approval to:

Execute an agreement between the City of Plantation and C & L Bus Co. Inc. for "Bus Transportation Services" in accordance with WB No. 054-26. The initial term of this contract shall be for one (1) year with the option to renew for three (3) additional one (1) year periods.

Issue purchase orders and process payments to C & L Bus Co. Inc. for "Bus Transportation Services" in accordance with WB No. 054-26 on an as needed basis.

Procurement:

Pursuant to City Code Sec. 2-226(b) the Procurement Department secured informal competitive bids for the above-mentioned services. On July 30, 2026, one (1) competitive bid was received. This solicitation was publicly advertised on the Demand Star website for fourteen (14) calendar days, broadcasted to 969 vendors, and had 18 Planholders. A copy of the one (1) competitive bid is attached for your review.

The numerical results are as follows:

The Procurement Department staff performed a review of the apparent low bidder (C & L Bus Co., Inc.) to ascertain submittal responsiveness. After careful consideration of all the information provided by the bidder, the Procurement Department staff concluded C & L Bus

Co., Inc. (apparent low bidder) submitted the lowest, responsive bid submittal.

The Parks & Recreation Department staff performed a review of the lowest responsive bid(der) to ascertain if they were responsible. After careful consideration of all the information provided, the Parks & Recreation Department staff has concluded that C & L Bus Co., Inc. is the lowest responsible bidder.

Based on the foregoing information the Procurement and Parks & Recreation Departments, request authorization and approval of the following:

- Execute an agreement between the City of Plantation and C & L Bus Co. Inc. for "Bus Transportation Services" in accordance with WB No. 054-26. The initial term of this contract shall be for one (1) year with the option to renew for three (3) additional one (1) year periods.
