Agreement No. 069-22: Supply & Delivery of Zinc Orthophosphate-Term Contract (Amendment No. 3)

Summary:

Requesting authorization and approval of the following:

To execute the third (3rd) Amendment between the City of Plantation and Amaya Solutions Inc. dba American Water Chemicals for Agreement No. 069-22; Supply & Delivery of Zinc Orthophosphate amending the agreement expiration date to January 17, 2027, and allowing for a rate increase.

To continue to issue purchase orders and process payments to Amaya Solutions Inc. dba American Water Chemicals for the "Supply & Delivery of Zinc Orthophosphate" in accordance with Agreement No. 069-22 and any associated amendments.

Procurement:

Approval was received by Council (Agenda Item No. 10 - Meeting date 10/12/2022) to execute an agreement between the City and Amaya Solutions, Inc d/b/a American Water Chemicals for the "Supply & Delivery of Zinc Orthophosphate" in accordance with ITB No. 069-22.

Agreement No. 069-22; Purchase and Delivery of Sodium Hypochlorite is set to expire January 17, 2026, if it is not extended/renewed. The Agreement contains a provision for four (4) additional one (1) year periods, provided the Contractor also agrees in writing to extension upon such terms as the City and Contractor agree. The City desires to execute the third of four (4) one (1) renewal/extension options, which includes a price increase of \$0.085 cents per Bulk Delivery and a \$0.008 cents per Gallon Totes.
