ITB No. 057-25; Hydrofluorosilicic Acid (Fluoride) Pump Out, Transfer, and Disposal

Summary:

Requesting authorization and approval of the following:

To execute a purchase order and process payment(s) to Action Environmental, LLC for "Hydrofluorosilicic Acid (Fluoride) Pump Out, Transfer, and Disposal" in accordance with ITB No. 057-25 for an amount of \$43,482.50.

Procurement:

Pursuant to City Code Sec. 2-220(e) the Procurement Department secured formal competitive bids for the above-mentioned services. On March 3, 2026, there were a total of seventeen (17) planholders for this solicitation, three (3) competitive bids were received, and this was also broadcasted to 472 vendors. This solicitation was advertised/posted on the Demand Star website for thirty-six (36) calendar days. A copy of the three (3) competitive bids is attached for your review.

The Utilities Department staff performed a review of the lowest responsive bid(der) to ascertain if they were responsible. After careful consideration of all the information provided, the Utilities Department staff has concluded that Action Environmental, LLC has submitted the lowest responsible bid.

Based on the foregoing information, the Utilities and Procurement Department requests authorization and approval of the following:

- Authorization and approval to execute a purchase order and process payment(s) to Action Environmental, LLC for "Hydrofluorosilicic Acid (Fluoride) Pump Out, Transfer, and Disposal" in accordance with ITB No. 057-25 for an amount of \$43,482.50.
