Pipe Bursting - SW 125th Avenue

Summary:

Requesting authorization and approval of the following:

Authorization and approval of a competitive procurement exemption pursuant to 2-226(g)(5) of the City's Code. Utilizing the pricing structure of an active public agency agreement (City of Boynton Beach) (ITB No. 25-020RB "Pre-Chlorinated Pipe Bursting of Potable Water Mains" set to expire August 5, 2028).

Authorization and approval to issue a purchase order and process payment(s) to Murphy Pipeline Contractors, LLC LLC for Pipe Bursting - SW 125th Avenue for a total amount of \$171,500.00 (see attached quote for additional details).

Procurement:

City determined that there is no need to pursue an independent competitive procurement, as the work/services mentioned herein has been successfully solicited and competitively awarded by a Florida agency. City of Boynton Beach publicly and competitively solicited for "Pre-Chlorinated Pipe Bursting of Potable Water Mains" (ITB No. 25-020RB). City of Boynton Beach awarded this solicitation to two Contractors Murphy Pipeline Contractors, LLC as Primary and Killebrew, Inc as Secondary, the agreement for Murphy Pipeline Contractors, LLC is set to expire August 5, 2028.

This solicitation and award complies with section 2-226(g)(5) of the City's code. Procurement has confirmed/verified that the unit cost(s) provided in the submitted proposal reflects the pricing structure of City of Boynton Beach's term agreement. Utilization of the pricing structure associated with City of Boynton Beach Agreement ITB No. 25-020RB; Pre-Chlorinated Pipe Bursting of Potable Water Mains allows the City to take advantage of City of Boynton Beach competitive process and pricing, and allows the City to expediate the work mentioned herein.

Based on the foregoing information, Utilities and Procurement Departments requests the following:

- Authorization and approval of a competitive procurement exemption pursuant to 2-226(g)(5) of the City's Code. Utilizing the pricing structure of an active public agency agreement (City of Boynton Beach) (ITB No. 25-020RB "Pre-Chlorinated Pipe Bursting of Potable Water Mains" set to expire August 5, 2028.
- Authorization and approval to issue a purchase order and process payment(s) to Murphy Pipeline Contractors, LLC LLC for Pipe Bursting - SW 125th Avenue for a total amount of \$171,500.00 (see attached quote for additional details).

Background:

Strategic Priorities: Planning for a Sustainable Future; Safe and Secure.

Engineering Department is conducting a paving/drainage project along SW 125th Avenue. The proposed project currently runs over an older 10" water main that Utilities did not plan on replacing for 2 - 3 years. With the mentioned project being a priority, replacement of the water main has been moved ahead of schedule to make the project more cost effective overall.

Utilities Department will be utilizing a trenchless method for replacing the water main known as pipe bursting.

This item is now ready for City Council consideration.
