Subject:

Agreement No. 079-21; Avista Technologies VITEC 5100 Scale Inhibitor (Amendment No. 2)

Summary:

Requesting authorization and approval of the following:

- Authorization and approval to execute the second (2nd) of two (2) one (1) year renewal options, extending Agreement No. 079-21; Avista Technologies VITEC 5100 Scale Inhibitor between the City of Plantation and Harn RO Systems, Inc. until August 26, 2026, providing for a price increase as reflected in the proposed Amendment No. 2 (attached), increased price(s) shall become effective August 26, 2025.
- Authorization and approval to continue to issue purchase orders and process payments to Harn RO Systems, Inc. in accordance with Agreement No. 079-21; Avista Technologies VITEC 5100 Scale Inhibitor and any associated amendments.

Procurement:

Based on the results of Single Source/Sole Source procurement process ISS No. 079-21 was awarded to Harn RO Systems, Inc. An agreement was executed for a three-year period (August 26, 2021 - August 25, 2024). This agreement also allows for two (2) one (1) year renewals. Harn RO Systems, Inc. is requesting a rate increase as reflected in the attached Amendment No 2.

Rate Change:

- From \$3,550.00 to \$3,650.00 (approx. 2.8% increase)

Note: This would be the first rate increase since the execution of this agreement (August 26, 2021).

This information was presented to the using Department (Utilities), they concluded that the requested rate increase was fair and reasonable based on the high-level professionalism and

services provided by the Firm over the past four years.

The attached Amendment No. 2 provides for the proposed rates. If approved the proposed rates shall remain firm until August 26, 2026.

Based on the foregoing information the Utilities and Procurement Departments requests authorization and approval of the following:
