Agreement No. 039-25; Municipal Solid Waste Consultant.

Summary:

Requesting authorization and approval of the following:

Approval of the Selection Committee scores and ranking identifying MidAtlantic Solid Waste Consultants, LLC d/b/a MSW Consultants as the highest scored/most advantageous Firm in reference to RFSP No. 039-25; Municipal Solid Waste Consultant.

Authorization and approval to execute the negotiated agreement (see attached) between the City and MidAtlantic Solid Waste Consultants, LLC d/b/a MSW Consultants for "Municipal Solid Waste Consultant." for total amount of \$97,400.00.

Procurement:

The City publicly solicited sealed proposals from qualified Firms pursuant to Sec. 2-220(b) and 2-226(b) of the City's Code, for Municipal Solid Waste Consultant (RFSP No. 039-25). On August 20, 2025 30 the City received a total of two (2) sealed proposals. This Request for Sealed Proposal (RFSP) was advertised/posted on the Demand Star website for fifty-one (51) calendar days. This solicitation was broadcasted to 1840 vendors/firms, and had twenty-seven (27) Planholders.

The Procurement Department performed a review of each Firm submittal to ascertain if they were responsive. All Firms were found to have submitted a responsive proposal. The responsive Firms were approved for the Selection Committee's review and ranking.

On September 19th, 2025 the Selection Committee held a public meeting to discuss and potentially score and rank Firms relating to RFSP No. 039-25. Below you will find the results of this meeting.

During the September 19, 2025 meeting the Committee opted to hold oral interviews and presentations with the two (2) Firms.

On October 13th, 2025 the Selection Committee conducted oral interviews and presentations with the shortlisted Firms. After interviews/presentations were concluded, the Selection Committee held a public meeting to discuss and provide final scores. Below you will find the results of this meeting.

Background:

Strategic Priority: Planning for a Sustainable Future.

The City Council has previously directed staff to plan to seek competitive proposals for municipal solid waste, recycling, yard waste and bulky trash collection and disposal services.

In order to prepare for this, staff prepared an RFSP for a solid waste consultant. The consultant will assist by making a recommendation to Council on the most efficient and sustainable collection method, assist with preparation and evaluation of an RFSP for a collection/hauler, assist with negotiation and drafting of a new Franchise Agreement, and be

available to staff to assist with the transition.

This item is now ready for City Council consideration.
